This sheet will serve as a checklist to ensure you have all the necessary information for your child to join the Island Aquatics swim team.

\$50 Buy Out Fee for Parent Non-Participation at each required event.
Replacement costs for gear will be charged when needed.
Island Aquatics Code of Conduct signed by the swimmer and the parent.
Swim Meet Fees will be paid at the end of each season.
I will not leave my child unattended before a coach arrives to practices.
**I understand and agree that I will pay the season fee for my child attending practices.
**I understand and agree that I owe for the entire 2025-26 Long Course & Short Course by bringing
my child to participate from ONE to all of the practices each month. Any other financial
arrangement must be pre-approved prior to the start of the next season.

Payment Options:

All payments are due in accordance to the Group Fees/Swim meet Fees/Club Activity Fees. An NSF charge of \$25 will be charged for any checks returned as unpaid.

Upon joining the year-round team, there is also an annual fee to USA Swimming, which all swimmers must pay. This covers their insurance while at the pool. Please make payment online for your USA Swimming Membership.

ISLAND AQUATICS CODE OF CONDUCT

- 1. All members of the Island Aquatics swim team must conduct themselves in a manner respectful of all policies and property at the Kihei Aquatic Center and other locations. Any violations of facility policies may result in suspension from the use of these facilities. This policy is also in effect at all out-of-town and out-of-state swim meets, activities, and travel trips
- 2. The following actions will not be tolerated from any member or parent/guardian:
 - a. Insubordination to any coach, meet official or person volunteering for IA.
 - b. Displaying or promoting unsafe actions in or around the pool or locker room.
 - c. Profane language.
- 3. All swimmers are expected to be suited up and ready prior to designated practice times.
- 4. All swimmers are expected to follow the directions and instructions of the coaching staff and designated chaperones.
- 5. All swimmers and spectators representing IA are to display proper respect and sportsmanship towards their competitors, other coaches, meet officials and the public.
- 6. The possession or use of alcohol, tobacco or any non-prescribed drug is prohibited within the swim meet areas.

Disciplinary actions:

The swimmer will be given a verbal warning and may be removed from practice, then allowed to return to the water.

The swimmer will be dismissed from practice and will remain on deck until the parent arrives. Parents will be notified to pick up their swimmer.

Discussion regarding the issue may occur <u>after</u> practice with coach, swimmer, parent and I.A. Rep. <u>only</u> if the Head Coach is available and all swimmers have cleared the pool. ALL DISCUSSIONS ARE TO BE ADDRESSED WITH THE HEAD COACH FIRST. At no time may a parent/guardian approach any other coach with disciplinary concerns. When the Head Coach is not available, please call 385-5332 to arrange a meeting or email <u>island.aquatics@yahoo.com</u>. Any other team questions or concerns are to be directed to Cathy Donohue, Team Operations, at the same number or email stated.

Any swimmer, at any time, can be suspended from the team for an indefinite period of time for extreme violations committed by the swimmer and or the swimmer's family member after a review by the head coach.
